DEFENDANT-APPELLANT'S BRIEF

- A recently discovered portion of an interview by Brenda Toppin is a good example of exculpatory material collected on a non-indictment child. "Child No. 5" was interviewed by Brenda Toppin. The interview was audio-taped. Ms. Toppin then apparently taped over this interview with an interview of Betsy Kelly. After the state cross-examined Ms. Kelly about a comment she made during the interview, the defense played the entire interview for the jury. The tape was introduced into evidence as Defendant's Exhibit No. 256, which has since been transmitted to this Court.

At the end of the tape recording is the last few minutes of Ms. Toppin's interview of "Child No. 5." The transcript of this portion of the interview is attached to this Brief with the name of the child obscured. Ms. Toppin did not bring any record of her interviews to court, defendants subpoena duces tecum having been quashed. She testified, however, that she used appropriate interview techniques, did not lead the children, and used the anatomical dolls in a professional and non-suggestive manner. (Tpp. 12,458, 12,461, 12,467-69, 12,473) The transcript reveals that, contrary to Ms. Toppin's testimony at trial, at least some of her interviews were recorded and then intentionally destroyed. It also reveals that Ms. Toppin's interviews were not only suggestive, but coercive to the point of brutality. The child's crying and pleas to stop are met only by Ms. Toppin's promise to stop when the child said what she wanted to hear. The tape also makes it clear that it was Ms. Toppin, not "Child No. 5," who manipulated and touched the dolls. See App. 8.

BT Inaudible . . . feel like heat...
M Say we're used to this . . . we have [inaudible] every night when we go to bed.
BT You do?
M Say yes ma'am, here you go ...
C It still hurts ...
M Well, give it a few minutes. It will take a few minutes.
C I'm thirsty.
M Ok. I'll tell you what, I'll get you some . . . what you want? You want 7UP?
C Uh huh.
M Ok, ask Ms. Brenda if she wants something to drink.

BT Can I have a little bit too?

C I'll give it to you.
BT Huh?

C I'll give it to you.
BT You want to give in to me?
C What [inaudible] knife.
BT I can small your Ben Gay.
C It don't smell good.
BT It smalls pretty good, it's not bad.
C Hey, I want, I want, I want to talk now.
BT Well, we have to talk about Mr. Bob first before we can talk. You have to tell me why you think he's a bad person sometimes. Sometimes is he a good person?

C Inaudible
BT You know I can't understand a word you're saying with that in your mouth.
C I said he spanks us.
BT He spanks you?
C He spanks us!
BT Why does he spank you? What do you . . . What do kids do when they get a spanking?

C They spank him right in the holster.
BT Right where the holster is? They spank you here? Or here? Or here? Or here? Or Here? Where do they spank you?

BT Your neck still hurt' n ? . . . Yes? Well tell me who Mr. Bob spanks and then Ms. Brenda will be almost through.
[Phone rings - RH gets it]
C Hello. Uh huh. Fine. Uh huh.
M Say a few more minutes.
C Ok, Ok, Bye.
M Was that Ms. Anne?
C Uh huh.
BT Ok. Well come talk to me so [inaudible].
M Real quick, gotta finish talking.
BT So we can...
C [Whines]...
M Well honey, what did you do to it?

C I was . . I was running in the street . . .
M Is that how you hurt your neck?
C Uh huh.
M It hurt before you hit the bed?
C Uh hum.
M Well, I told you not to go outside, didn't I? . . . Alright, look, you're almost finished...

C Uh ugh, uh ugh . . . while you were on the telephone I went outside.
Pause
M When you were on the telephone you went outside . . . Uh. You did not go outside when I was on the telephone.

C Um hum.
M No you didn't. You told me that Mr. Bob spanks. Is that the truth or is that make pretend?

C Its the truth.
BT Ok. Can you tell me who Mr. Bob spanks?... Its Ok to tell.
C Ummmm . . . Annie Baker.
BT Does he spank Annie Baker, does he spank anyone else?
C Uh Uh.
BT Just Annie? . . . Ok when you told me that you got a spanking was that the truth, or was that make believe?

C It was make believe.
BT That was make believe. Ok. When Annie Baker got a spanking was that the truth or make believe?

C The truth.
BT The truth. Ok. Um. Can you tell me if um . . . any kids in that class are unhappy kid because anything that Mr. Bob does?

C Know what mommy? What is the right here?
M Inaudible

BT Answer me real quick, so you can go play.
C Uh huh.
$\mathrm{M} \quad$ Isn't it fun to talk?
C Uh uh [No].
M No...
C I want to go ...
BT Ok. Well tell me real quick who's unhappy if Mr. Bob does things they don't like. Is anybody unhappy?

C I want you to come tomorrow.
BT You want me to come tomorrow? Why do you want me . . . Will you talk to me tomorrow if I come?

C [No response]
BT Ok. Would you tell me . . . does Mr. Bob ever tell you not to tell anything?
C [No response]
BT Can you tell me what that is? . . . You know its ok. Ms. Betsy and Mr. Bob want everybody to tell everything so so that everybody will know what goes on at the daycare . . . Can you tell me what Mr. Bob told you not to say?

C He said not to say do do and pee pee.
BT Ok. Were they words that you aren't supposed to use?
C Use?
BT Um. Are they words you're not supposed to say?
C Foo foo?
BT What's foo foo? . . . That's a dog!
C Uh uh.
BT What is it?
C A cat.
BT A cat?
C [Whines]...

BT You hurt your neck...
M Yea, he did.
BT Mommy give it love and kisses and it'll be all better. Alright. Let me ask you one more thing and then I'll be all through RH and you can go play. Ok? ... You see my little dolls here you were looking at?

C Uh huh.
BT Ok. What I need to know. I want to know if Ms. Shelly or Ms. Betsy or Mr. Bob anybody in your class has any touched any of the kids here, here, or here? . . . Has anybody ever touched the kids there?

C Ummm... There.
BT Where there? Show me where. You can hold him.
C Right on the stomach.
BT Ok. Right here?
C Uh huh.
BT Ok. Have they ever touched them anywhere else?
C Uh uh [ No ]
BT Ok.
C But get the other baby dolls out.
BT I got a little girl dolly too see.
C Um hum.
BT Has Mr. Bob ever touched any of the little girls or Ms. Shelly touched any of the little girls anywhere?

C Why does she have these sihoes on?
BT She has patten shoes on.
C What?
BT She has to wear shoes too. Don't take her pretty shoes off, her feet will be cold.
C Uh huh. And she'll cry.
BT That's right she will.
[Inaudible]

BT Look at her hair sticking straight up already.
M Her hair looks like Meredith's does.
C Get the other baby doll out.
BT No. We can't play dollys. You got to go bye bye and I got hurry up and leave so we need to finish up. Is there any thing that you think I should know about daycare that that people are not happy there . . .

C Nooo mommy! . .
M $\quad \mathrm{RH}$, go ahead and finish talking and then we can go on.
BT Is there anyone unhappy at day care?
C Uh uh [No].
BT No? . . Did you really get a spanking or was that make believe?
C It was make believe.
BT Ok. How about Anna . . . Was it Anna?
M Annie.
BT Annie. Did she get a spanking, or was that make believe?
C It was . . . she got a spanking.
BT She did. And who spanked her?
C Mr. Bob.
BT Ok. Well listen, I want to thank you ...
